Cyclops has started the repair and installation of new cameras.


Graffiti – will contact Ohio Pressure wash to clean the graffiti.

Brad Silvers is getting quotes from Agua Doc to put a fountain in the pond to help keep clean.


Mr. Elliott, Director of flag football program, will begin September 16 to October 28. He will pay \$250 per week.

Subject: Baseball Park forest property abutting our homes 100, & 200 The Greens in The Woods of Avalon.


