SUMMARY OF MEETING:

Commissioners reviewed previous approval (at Nov. 12, 2021 meeting) of a request from the Howland Schools to proceed with the initial phase of a project (Howland Park Drainage/Bullpen-Batting Cage) to apply to the Army Corps of Engineers for Jurisdiction. Jeff Mihalik of JM Environmental Consulting, reviewed the preparation and submission of the Aquatic Delineation & Jurisdictional Request to the Army Corps of Engineers. Dale Gebhardt shared what has occurred since that meeting which includes:

- 1. The application to the Army Corps of Engineers was approved on Dec. 22, 2021.
- 2. The Howland Township Trustees approved donating \$70,000 of ARP Funds to be directed to the Howland Park to be used for the Drainage portion of this project.

Commissioners discussed accepting the \$70,000 ARP Funds and acting as escrow agent paying the bills associated with the Drainage portion of the project from the ARP funds provided. The Bullpen/Batting cage and associated improvements would be covered by private donation, with no funds coming from Park operating budget, and will be outside the scope of this project.

Commissioners discussed authorizing JM Environmental Consulting, LLC to proceed with submission of NWP 42 pre-construction notification to the district engineer at the US Army Corps of Engineers.

Commissioners discussed getting quotes for the installation and engineering of the project. Dale Gebhardt explained the project would need to be started soon, as the first baseball game is scheduled for March 28, 2022.

Discussion was had regarding funds. If funding of the project exceeds \$70,000, Dale Gebhardt will cover it up to \$15,000. Dale Gebhardt will provide the park with a letter evidencing this commitment. The money will not come from the park operating budget. Discussion and approval was made regarding appointment of Dale Gebhardt as "Project Manager" of the stormwater installation project.

Discussion for 2022 projects will include:

Cameras, Morgandale Park upgrade, repair tennis court, reviewing the use of the basketball court to a pickleball court.
