- 1. Trent Cailor came to address Commissioners' questions regarding insuring the baseball and softball fields at the park. There was discussion about liability. Mr. Cailor recommended Howland Park should verify through its lease with Howland Schools who is responsible for insuring the real property (dugouts, fencing, scoreboards, etc.) of the ball fields. A question of who is responsible for the recently added batting cages was also discussed. Another recommendation was for the Howland Park to ask Howland Schools to provide the park with a certificate of insurance naming the park as an additional insured with regards to Rosegarden, especially as the park is not responsible for the upkeep and maintenance of the ball fields. Commissioner Pompelia made note that the Commissioners have no issues, but wish to be certain they have the coverage and want to be good stewards of the township money. Commissioner Gault explained the goal is to educate ourselves regarding park responsibility. Commissioner Gault will approach Howland Schools Superintendent Spicher to discuss the title search that the Commissioners have undertaken to learn more about the property leased by the Park and to discuss the lease to determine if any modifications need to be made.
- 2. Kenneth Abell with the Howland Rotary attended to get more information on the camera system at the Park. He reported the Rotary is aware of the vandalism problem and is considering ways to help the board with the expense of security. Commissioner Pompelia explained the park board approved Cyclops Technology Group for providing a camera tower that will be able to capture video in nearly the entire park. The board will pay \$14,695 for a five year lease for this camera and an additional camera to cover the Lake Pavilion area. The board will then pay the lease in monthly installments of about \$245. The Cyclops Group will maintain the cameras. The board is currently looking at ways for the tower to "blend" in with the park aesthetics. Mr. Abell had questions about how vandals will be punished after they are identified. The Commissioners explained that prosecuting vandals involves filing charges with the police department.
- 3. Commissioners noted that the Howland Community Tree Lighting was a phenomenal success. They thanked volunteers Jim Rollison and Carly Saxon for hanging the lights around the pavilion. They also thanked Dan Monroe for picking up the Christmas tree from Storeyland and the Howland Fire Department for their help coordinating the event. The Commissioners plan to meet next month with Township Trustee Darlene St. George to discuss ideas for next year.
- 4. Brad Silvers reported to the Board that the Disc Golf course has been played more than 500 times since it opened in late September. Attendance at the course is monitored by a disc golf phone application that shows when the course is played. There is a winter disc golf event planned for February 18, 2023 that is expected to draw around 75 disc golfers.
