Commissioner Pompelia: Safos Development: Flooding conditions from the left of the bend by adjacent properties north to Safos development and including ditch. Will look into getting cleaned out. Will request quotes on this project.

Commissioner Gault: Asked Commissioner Pompelia to get additional quotes for pads for bench that is being purchased in memory of someone.

Commissioner Gault: Logan's Landing Project reached out to the park regarding adding inclusive playground places to Tiger Town II. Commissioner Pompelia will reach out to discuss Logan's Landing Project doing fundraising for the park to be able to add pieces to Tiger Town II.

Commissioner Pompelia: Between August and September looking at the quote for paving from the gas well to the stop sign and skim batch in the area by the ball field. This project will depend upon the cost received from the accepted quote.

Commissioner Gault – A tree at Bolindale Park has loose limbs that need dealt with. Vivian will contact Marvin's Tree Service as these loose limbs present and immediate danger.

Commissioner Gault: Pickleball requested that the parking lot at Bolindale be lined and designate a handicap parking space. Commissioner Seman will get quotes and commissioners approval proceeding.

Commissioner Gault stated that Administrator Pantalone received a call from Believer's Christian Church and they would like to help clean-up Morgandale Park. Commissioner Gault will reach out to them to coordinate.
